STALLION SERVICE REPORT

All owners of pure-bred registered Morgan Stallions which have served pure-bred Morgan Mares by natural service or artificial insemination during the calendar year, shall submit a stallion report to the Society's office at the end of the breeding season - not later than 31st December. This report shall be prepared from the Stallion Owner's records. Additional Stallion Report forms will be furnished on request.

1. Every Stallion owner must report both pure-bred registered Morgan Mares and all other mares (whose offspring will then be entered in the BMHS Part-Bred or Anglo Stud Books), bred to the stallion during the year whether such mares are owned by the stallion owner or by another person. A separate report must be made for each stallion each year.
2. All pure-bred Morgan mares and dams of Part-breds/Anglos, bred (not just in-foal), must be listed with the names of the owners and all dates of service.
3. Dates of Shipment of semen from the stallion's location must be indicated, together with related BMHS or AMHS permit number.
4. This report must be signed by the owner(s) of the stallion or, in the case of imported semen, the owner/purchaser of that semen in such shipment is deemed the stallion owner and as such should sign the report for the stallion. In the case of leased stallions, the lessee(s) must sign the report and a lease agreement be submitted to the registrar.
5. All stallions siring foals must have their blood-type recorded with the appropriate authority recognised by the BMHS.
6. The recorded owner or lessee of each mare is the person who should contract the breeding.

Send this completed report to the registrar (address as above) and retain a copy as a record.
